CiiA offers two (2) plans for Residential & Small Business. Please indicate your preference below:

Residential **Plan CI**: 512kbs download 128kpbs upload - \$69 month for 3GB (\$79 for 3GB+)

- Rate Limited after 3GB Download

Small **Business Plan CI**: 512Kbs download 128K upload - \$225 month

- Rate Limited after 8GB Download

CiiA is a public company limited by guarantee - established and operated as a community-owned not-for-profit entity.

In order to connect your premises to our network you require a small network appliance. All subscribers shall provide CiiA with a deposit of \$200, which covers required broadband subscriber equipment (not including purchase of broadband router). The deposit will be returned in full should you cancel your subscription. If you feel the deposit would constitute a significant hardship you may write to the Board and we will consider waiving the deposit on a case-by-case basis. In the event that your premises is in a low signal area and requires a network appliance with an external antenna, then an extra installation cost may apply.

The new plans do not have any download limits. Subscribers must abide by our acceptable use policy (AUP) and may NOT host Internet servers or otherwise disrupt or abuse the CiiA network. If you are found to be in breach of the AUP we reserve the right to suspend your service. In the event we feel your use is disruptive we will attempt to work with you to bring your use into compliance before suspending service.
